## \*\*MEDIA & EXECUTIVE SESSION\*\*

Representatives of the news media and designated staff shall be allowed to attend the Executive Session. Executive Session will be held in the Superintendent's Office. Representatives of the news media are specifically directed not to report on or otherwise disclose any of the deliberations or anything said about such subjects during the Executive Session, except to state the general subject of the session as previously announced. No decision may be made in Executive Session. At the end of the Executive Session, the Board of Directors will return to open session.

Media can be excluded for the following reasons:

- When the Board meets with labor negotiations to discuss bargaining strategies;
- When the Board meets to consider expelling a student;
- When the Board discusses a student's confidential records; and
- When the Board discusses litigation against the district or community college in which the reporter or the reporter's media organization is involved.
